The Agenda

1. Opening

Jesse opens the GA and thanks everybody for attending.

2. Sequential ordering of the agenda

Jesse goes over the proposed agenda; there are no remarks so the agenda is
approved.

3. Additional Board Members

Esther again explains the boards' reasoning for changing the statutes. She furthermore explains the proposed solution in case of a tie in the board: if after two meetings the board still isn't able to come to a decision and has asked advisory council for advice but is still unable to resolve the issue, the board (majority) has to agree that the issue will be taken up to the GA.

- Q1: (Job) Could you please explain the voting procedure and what it means to abstain?
- A1: Esther explains that choosing to abstain means that you are against the motion as proposed, not against it in principle.

The motion is passed. The votes are as follows:

In favor: 88 Against: 3 Abstaining: 7 Total: 98

4. Membership fee

Jesse explains that the membership fee is currently 40 euros, and this board had 10 euros extra to spend due to left over money from last years board. In the future, especially because the association is growing, this amount will no longer suffice, also because there will most likely not be any more money left over after this year. Jesse/the board proposes to increase the membership fee by 15 euros to 55 euros, the 10 years

- Q2: (Jelmer) Have you talked to management about this?
- A2: (Jesse) Yes we have talked to MT about this, they say that we have to get a positive response from the GA/members and then the board submits a proposal to the school about this.
- Q3: (Jelmer) Will the additional 15 euro be allocated from AUC or will members have to pay 15 euro more?
- A3: (JW) This is up to AUC to determine (if it is reallocated or added to the tuition fee).
- Q4: (Victorine) Have you explored the option of getting this money from external parties?



- A4: (Jesse) Yes, we are looking into acquisition already but this membership fee increase will most likely be necessary regardless, and JW adds that this amount is continuous and independent of contracts/liabilities.

The votes are as follows:

In favor: 76 Against: 17 Abstaining: 5 Total: 98

5. The audit committee

Jesse welcomes the audit committee and asks them to present their half-year results. Ivana notes an improvement in the updating of financial records, leading to increased accuracy and transparency. Moreover, they suggest a subscription to an accounting program, and to separate the audit for AUCafé and TEDx. Finally, they suggest doing a market analysis for merchandise before ordering it to make sure things are bought responsibly (will actually get sold).

 - i. Roos van der Deijl proposes a 10 euro discount (from 5) on 30 sweatpants for sports players (?) from unforeseen costs. There are 19 in favor, 35 against, 18 abstain; there are 3 proxies in favor, 3 proxies against, and 5 abstain. The motion does not pass unfortunately.
 - ii. The GA approves the budget.

 - i. Teun Strikkers motions to add 30 euros to the energy conference for an extra speaker from unforeseen costs. The GA approves this motion.
 - ii. Teun Strikkers wants to reallocate 50 euros from the toys from trash workshop to the energy conference. The GA approves this motion.
 - iii. The GA approves the new budget.
 - d. Cuisine
 - i. Beau would like to increase the equipment by 50 euros for a new blender from unforeseen costs. Q6: (Sophia) Cuisine do you already have a blender? A6 (Beau) The blender broke. The GA approves this motion
 - ii. The GA approves the new budget.
 - e. AUCafé
 - i. Q7: (Clarie) Why would there be a negative difference if the old one is higher than the new one?
 - A7: (Jesse) Their income is less that's why the new cost is lower.
 - ii. Maarten motions for 100 euros of transition money and would like to reallocate this from their 'atmosphere creation'. A8: (Maarten) The



transition wasn't taken into account at the beginning of the year and wasn't in the budget. Q9: (Sanna) I'm slightly confused, if your transition has already passed and you spent the money why do you need more money now? And can you still get reimbursed for an expense you've already made if you ask for approval afterwards? (JW) The GA can decide to approve an expense if the board doesn't. A10: (Willem) This money is for the reimbursing of the transition that took place in December. A10.2: (Willem) This money was spent from people's own money and they would now like to get this reimbursed. There are 49 people in favor, 17 against, and 3 abstain; 3 proxies in favor, 3 against, and 5 abstain. The GA approves this motion.

- iii. Maarten motions for a 100 euro reallocation from cloth for curtains to a barbecue for the new bartenders. A14: (Willem) When we started we didn't know all of these amounts and what was needed and how much it would costs, and we realize now that the bartenders are so vital so we'd rather move some money to that from the furnishings that are now turning out to not be that necessary. Yaron Zonneveld adds that some of the refurnishing was also done by the municipality. Dante feels that the money that isn't going to be spent anyway on furniture should just go back into the big pot and be redistributed to all committees from there. Willem explains that there is an educational value to the transition and that it isn't only for fun. Jerome adds that if the barcrew is properly trained, the café will be run better and result in a higher income. There are 32 in favor, 33 against, and 15 abstain; 2 proxies in favor, 5 against, and 4 abstain. The motion does not pass.
- iv. JW proposes to remove the 200 euros unforeseen costs in the AUCafé budget and put this back into the big pot. The GA approves this motion.
- v. Henriette motions to remove the 100 euros from cloth for curtains and put this back in the big pot. The GA approves this motion.
- vi. Q11: (David) How come you have so much money unspent? A11: (Willem) In the first few months it was unsure how much AUCafé had to pay for themselves and what the municipality would pay for, and just now the renovations are coming together, so the money will be spent this semester.
